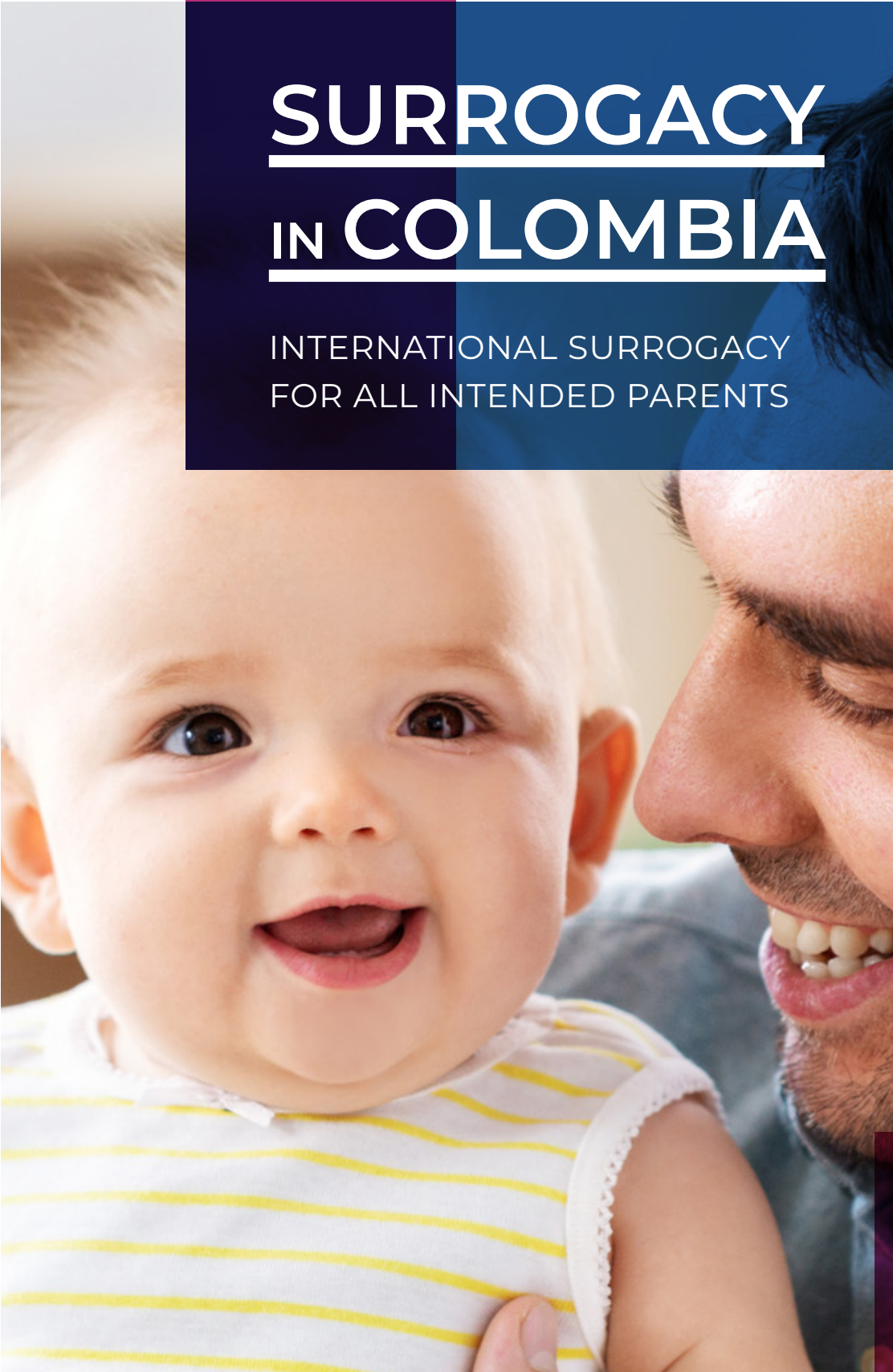

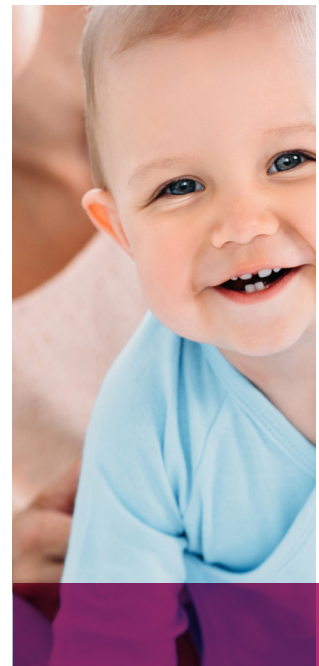

LEGAL FRAMEWORK

COLOMBIA SURROGACY

Assisted reproduction, including surrogacy, has been established for many years in Colombia. In 2015, the Constitutional Court of Colombia ruled that surrogacy arrangements were valid & enforceable.

While the Colombia legislature has still not passed any explicit regulation, the Court upheld the rights of families conceived by IVF and surrogacy.

The Courts uphold three important points:

Surrogacy Agreements

The court found that assisted reproduction, including surrogacy, is legitimate and legal under the Colombian Constitution. Surrogacy agreements are valid and enforceable. Children born with “scientific assistance” have equal rights under the law, including the right to their biological family.

Same Sex Couples and Singles

Colombia supports same-sex marriage, adoption and procreational rights. In 2016, The Constitutional Court ruled that same-sex couples and singles have the same rights and obligations as heterosexual couples. The Court also held that children of same-sex parents have equal rights to be part of a loving, caring family.

Filiation & Parental Rights

Although the birth mother is initially inscribed on the baby’s birth certificate, Colombia law allows Intended parents to demonstrate via DNA evidence the true parentage of the baby. The Court of Justice ruled in 2017 that babies born via IVF and surrogacy have the same legal status as adopted and naturally born children.
